WITHDRAWAL/REFUND POLICY

Refund policy: A minimum number of campers are required for camps. We will notify registered campers at least two weeks before the start date if a camp has not reached minimum enrollment. The full camp fee will be refunded if a camp is cancelled by the Mills Regional Health Education Center.

Withdrawal policy: Campers who withdraw less than two weeks prior to camp will receive a 50% refund. No refund after camp starts, except for a serious injury or illness.

FREQUENTLY ASKED QUESTIONS FOR PARENTS

Q: Does my child need to bring a lunch or money for lunch?

A: No, lunch is provided through High Point Regional Health and the cost is included in the registration fee.

Q: What if my child is a picky eater?

A: We have designed kid-friendly, yet healthy meals and snacks. Your child will be given a variety of foods served each day. If your child has an allergy or medical condition, we will accommodate accordingly.

Q: Does my child need money for activities?

A: All activities and features of the HealthyU camp are included in the registration fee; there are no additional fees.

Q: Is there a 3-day camp option available?

A: No, our Healthy U Summer Camp is a 5 day camp with a different theme each day. It has been designed for children to attend the whole week.

Q: Do you offer an extended day program?

A: No, camp begins at 9:00 every morning of the week and ends at 1:00 each afternoon.

Q: What happens if there is an emergency and I cannot pick up my child at 1:00?

A: Campers' days end in our Wellness Discovery Rooms and staff members will be available to supervise your child's play until your arrival. If you are running more than five minutes late, please be sure to call our office to alert camp staff.

Q: Where do I drop off and pick up my child?

A: Each day you will drop your child off at the main entrance to the Millis Center, sign them into camp and they will wait in the lobby, accompanied by a staff member, until all campers arrive. You will pick your child up in the same location, signing them out before you leave. The camp liability waiver asks for names of people approved to pick up your child.

Q: What are the qualifications of your staff members?

A: All staff members have all earned either a bachelor's or master's degree in health promotionrelated fields. Our staff biographies can be found on our website: www.millishealth.com

Q: Is there a limit on the number of campers?

A: Our maximum number for each camp is 20 children. We want to ensure each child receives quality education and attention throughout the week.

Q: Are their clinical professionals available in case of a medical emergency?

A: Yes, we are located on the High Point Regional Health campus with access to physicians, nurses and specialists.
